<sup>2</sup> In England, Wales and Northern Ireland, you will usually need to pay doctors' fees as well. This is the charge for two doctors to sign the Medical Certificates for Cremation.

We are a member of the National Association of Funeral Directors and subscribe to its current Code of Practice, a copy of which is available upon request. We aim to act in a professional manner and provide a courteous, sensitive and dignified service to you.

### **Payment Arrangements**

The funeral account is due for payment within 30 (thirty) days of our account, unless otherwise agreed by us in writing.

If a Payment Plan is required, we ask for a deposit to be paid (normally the 3<sup>rd</sup> party costs) and the remaining balance to be split into 12 monthly payments, with the account to be settled one month after the first anniversary of the funeral.

Terms over longer than one year will incur an interest charge (compound, monthly) of 4% above our bank's Base Rate in force at the time.
